HISTORY

Since 2009, New Life Mission has met homeless mothers with children where they are: living in cars, tents, pay-by-day motels and on friends' couches. Our four-phase residential program not only introduces them to tools and resources for true life transformation, but also brings to each and every family the life-saving truth of the Gospel.

A divine collision of events in the summer of 2009 led a property owner to partner with New Life Mission, making available a 12-unit apartment complex, now named Casa Carol. In 2018 a 5-unit apartment complex was added, now named Joy's Place.

In 2020, the Life Transformation Center was purchased near the highly visible corner of US1 and Eau Gallie Boulevard. It consists of five commercial buildings fronting US1 and eight small single-family cottages on a residential street behind with a playground and courtyard area.

We are proud to be debt-free on all three campuses and have never utilized government funding - a principle that we pass on to the families in our program.


These three campuses have the capacity to serve 21 families. With the growing need in our community, in May 2021, we purchased 25 acres in the heart of Melbourne. This capital campaign will allow us to open and operate New Life Village.

OUR MISSION

In a Christ-centered environment, we equip homeless moms to transform their families for generations. Through education, accountability, and goal advancement, our program empowers families to become self-sufficient and break the cycle of homelessness.



Therefore, if anyone is in Christ, the new creation has come: The old has gone, the new is here!



Located on 25 acres at the end of Croton Road in Melbourne, FL, is a gated and secure property. Seven buildings and a large outdoor gazebo currently exist on approximately 5 acres of mowed land (photo above). Operated for the last 30-plus years by Children's Home Society (and previously Hacienda Girls Ranch), this property was a safe haven for children in state custody.

This property includes:

- 2 residential buildings built for group-style living
- 4 quad apartments with shared kitchens
- 2 large storage buildings and a smaller storage shed
- A headquarters building with offices, meeting space, kitchen and dining area

THE VISION



Over the past 12 years, our donors have lifted this ministry to heights! With God's provision, our vision is to have capacity to serve 100 families at a time. With your help, New Life Mission is poised and ready to serve the Brevard County community for decades to come.

Most importantly, this Village is ONE physical location, providing all these services plus the spiritual and emotional village to carry families from homelessness to self-sufficiency. Our other campuses can then be used for affordable housing for New Life Mission graduates.

New Life Village will provide:

- Stable housing for more families
- Kids Academy child care center
- On-site case management
- Financial coaching
- Life skills classes
- Bible study sessions
- Transformed Shop warehouse and production center
- Gated security for residents and children
- Land to add multipurpose space for classes, chapel and dorms
